2. Co-Chairs Report

Co-chair Louise Cordeiro was not able to attend

- **Backpack Initiative:**
 - 40 backpacks were filled
 - 7 backpacks included lunch bags and water bottles
 - 12 backpacks with no water bottles or lunch bags
 - There are still more supplies and 14 additional pencil cases.
 - CSC will circle back to determine if the remainder or a portion of the item go to other school communities in need.
- **Open House BBQ:**
 - BBQ was a subsidized event and not a fundraiser.
 - There were discrepancies in pricing for the orders on the Online Cash portal – the School Board is looking into this issue as there seems to have been a computer glitch
- **Krispy Kreme Fundraiser**
 - 87 out of 100 boxes have been sold
 - Andrea Baranowski take the lead for the fundraiser. Doughnuts will be picked up by Andrea, and council members will assist in distributing the doughnuts to students between 2:30 and 3:30pm on Monday, October 21st.
 - Two additional Krispy Kreme fundraisers will be held in February and May 2025
 - **Action Item:** Natasha Almedia will reach out to Krispy Kreme Contact to solidify fundraising dates for 2025/26
- **Front Garden Enhancement**
 - Funds approved from last meeting (\$1000)
 - "Go Wild Grant" 2024/2025 (\$1500 per institution)
 - Andrea Ellery- Fernandez volunteered to draft proposal
 - Students and parents can participate – it can be a community event during the implementation phase
 - Mr. Torres and Ms. Cuifo is supportive.
- **City of Brampton Programs**
 - Free swimming program for grades 3 & 7
 - Teachers and staff will have to commit to including programming.
 - Council is able to review other programming suggestions that require funding.
